

# The Prevailing Insanity

## Introduction

The world is mad! You hear people complain about this everyday. Older people have been saying this for many years now but even younger people are beginning to feel that everything has gone awry. So blatant are the insane policies being rolled out by national governments. When Andrew Bridgen MP explained to Parliament about the dreadful and insane issues being taught to young children, the house ignored him completely but the policeman on duty burst into tears saying, *'Do we no longer care about our children?'*

The sort of insane actions appearing in society can be shown in just a few examples, without needing additional commentary:

- Massive inflation directly caused by the government printing money to stop people working.
- Transgenderism being taught in schools as normal (instead of psychotic) behaviour. Teachers affirming this position and castigating young children who stand up in class for common sense and true biology. Thus teachers tell lies while sane kids opposing this get shut down and expelled.
- Children identifying as a cat (and responding to teachers in meows) or as a moon.
- Green councils closing down roads in LTN cities like Oxford or closing down road lanes in Brighton and Oxford. This results in far greater exhaust pollution than before as cars idle and queue. In Oxford's 15-minute city pollution is said to increase 66% by closing roads according to its own commissioned report.
- The multiple forms of insanity of Climate Change Net-Zero which achieve nothing for the ecological system but destroy civilisation.

This paper seeks to analyse this prevailing insanity and identify the players behind it.

## Why are these crazy policies appearing?

### **It stems from leadership submitting to idiotic ideas**

The nutty strategies on the ground emanate from the crazy ideas of people in government ministries and local government. This means that ministers in charge of these departments must be insane. They introduce policies that cost a fortune and do actual harm to the population, such as crashing businesses, damaging the economy, creating inflation, introducing social repression, hindering free speech and more.

However, far from being haphazard and random, these crazy policies are part of a unified strategy to ruin society from within. The executive, the opposition, the civil service, academia, mainstream media and all subsidiary departments are committed to the same goal: destroy Western society from within.

### Where did this come from?

Cultural Marxists (and others)<sup>1</sup> formulated plans to take over Western societies, institutions, governments and cultures by hidden subversion and corruption tactics. This was derisively called, ‘*the long march through the institutions*’. The goal was to infiltrate every organ of society and fill it with Socialist / Marxist activists with the objective of destroying all the Christian, rational and democratic principles in culture.

The strategy, that in principle goes back to the early Fabians and Antonio Gramsci in the early 20<sup>th</sup> century, actively stems from the Frankfurt School in the 1930s. Everything was to be corrupted from within and ruined so that society stank and people were filled with despair. The hope was that this would enable a Marxist cultural revolution without a violent uprising that had failed to arise after WWI as the Marxists had expected (except in Russia).

I want a culture of pessimism ... a world abandoned by God.

I saw the revolutionary destruction of society as the one and only solution. ... A worldwide overturning of values cannot take place without the annihilation of the old values and the creation of new ones by the revolutionaries.

The evolution won't happen with guns, rather it will happen incrementally, year by year, generation by generation. We will gradually infiltrate their educational institutions and their political offices, transforming them slowly into Marxist entities as we move towards universal egalitarianism.

Given this situation, I suggested in ‘Repressive Tolerance’ the practice of discriminating tolerance in an inverse direction, as a means of shifting the balance between Right and Left by restraining the liberty of the Right.

We must organise the intellectuals and use them to **make the Western civilisation stink**. Only then after they have corrupted all its values and made life impossible, can we impose the dictatorship of the proletariat.

Make life impossible for everyone.

### **How did this happen?**

Socialist and Marxists gradually took over all the important jobs and influential positions in society over several decades. This particularly accelerated after the 1960s social revolutions. By corrupting education systems they could grow adults into their image. By using conditioning programmes (like Common Purpose leadership training) they could brainwash adults not yet in conformity. By threats and bribes they could force people to bend to their will.

It took years of subversion to grow. The subversion by stealth from Cultural Marxists and others resulted from:

#### *Corruption of education*

This led to dumbed-down teaching of a very low standard. GCSE and A-level results were tampered with to accommodate lower performance. Studies have shown that current A-level grade A+ students were unable to pass a 1950s 11-plus examination. That means that the brightest 16-year old students today were dumber than 1950s 11-year olds. This means that people now in power are not intellectually able to be in positions of power. They are dumb.

#### *Lack of meritocracy*

There are teenagers that do get a good schooling, from home education, foreign teaching or from private old fashioned schools. The problem is that various social filtration systems (ethnic quotas, affirmative action, sexual discrimination etc.) often filter out good quality people and let less qualified people get the job. The RAF has just been officially castigated for doing exactly this. This means that rarely do the best people get the top jobs in government or places of power. Instead the places go to sycophants and group-thinkers.

#### *Submission to GroupThink*

Through social conditioning, that starts in schoolchildren from an early age, people are taught to conform to GroupThink. The nation is producing young adults that are compliant to certain agendas that are considered to be axiomatic<sup>2</sup> (e.g. Green ideology, transgenderism, DEI, ESG etc.). No one considers rebelling against these false axioms on the basis that they are insane or irrational. No one demands evidence that an accepted axiom is in fact true. For example the Climate Change agenda has no evidence whatsoever. It is a folly based on corrupt computer models. But people will literally suffer for this agenda.

#### *Lack of courage*

Few modern people have the courage to stand against the flow of social repression. Hardly any have the courage of the diminutive Kellie-Jay Keen-Minshull (Posey Parker) who is standing up for women's security and gets attacked by mobs of men waving sticks while claiming to be women.

#### *Greed*

Many politicians are simply venial and have their nose in the trough. They do what they are told by overseeing powers, no matter how insane, as long as they are paid.

### *Blackmail*

It has long been alleged that many people in the halls of power have dirty secrets for which they are blackmailed into conforming to directions from others. One example of this is paedophilia, which has been openly admitted by a Tory chief whip as a common problem amongst MPs.

### *Continual conditioning through the bought media*

The various media organisations (the press, magazines, scientific and technical journals, television news, entertainment etc.) all sing from the same hymn sheet to put over the agenda of the Global Elite cabal. Bit by bit, week by week, various messages are ingrained into society so that propaganda pieces became axioms. These conditioning messages include a wide variety of topics, such as:

- EVOLUTION IS CORRECT; CREATION IS WRONG. [Even though there is no proof whatsoever for it.]
- UNIFORMITARIANISM IS CORRECT; CATASTROPHISM IS WRONG. [Even though observation of physical phenomena proves this wrong; e.g. the Mt St Helens volcanic eruption and subsequent fast topographical changes.]
- RIGHT WING POLICIES ARE RACIST, DISCRIMINATORY AND HARMFUL. [This ignores the historic benefits of conservative Right-Wing policies and tars all with the harms caused by extreme Far-Right fascists. Both Far-Right (e.g. Mussolini) and Far-Left dictators (e.g. Hitler, Stalin, Mao, Pol Pot) have been negative.]
- SOCIALISM IS KIND AND CARING. [Tell that to the 100 million killed and tortured by it in the 20<sup>th</sup> century.]
- CHRISTIANITY IS INTOLERANT, COLONIAL, RACIST, PRIVILEGED AND EVIL. [This contradicts the massive good that Christianity has done throughout history; more than any other religion or institution.]
- THE BIBLE IS IRRATIONAL, RACIST, AND INTOLERANT AND HAS NO PLACE IN MODERN SOCIETY. [This is just a plain lie. How can ‘love your enemies’ and ‘do good to them that hate you’ be intolerant and racist.]
- JESUS DIDN’T EXIST. THE TEACHING ATTRIBUTED TO HIM IS IRRELEVANT. Modern philosophers have more authority and wisdom. [Secular historic sources mention Jesus and describe him as a godly spiritual leader. His teaching has informed cultures, societies and individuals in a benevolent direction and has even established national laws.]
- WHITE PEOPLE ARE PRIVILEGED, CONNECTED TO SLAVE TRADING AND ARE THE INHERITORS OF COLONIAL IMPERIALISM AND RAPACITY. [Simply not true. Many White people were enslaved for centuries. Many White people were poor and downtrodden or suffered in massacres. The British slave trade lasted about 200 years and was a small part of the economy then Britain terminated slave trading at home and abroad. One can argue that, despite some flaws, British colonialism did more good than harm.]
- THE BRITISH EMPIRE IS THE MOST EVIL DOMAIN IN HISTORY. [It was probably the best. Compare Islamic empires that killed 700 million people in 1400 years and enslaved millions more.]
- ABORTION IS A WOMAN’S RIGHT TO SELF-EXPRESSION. A FOETUS (EVEN FULL TERM) IS NOT A HUMAN BEING. [Scans have proved that a foetus is clearly a live human being; responsive to stimuli at an early stage in pregnancy. Abortion is murder.]
- VACCINES ARE SAFE AND PROTECT US FROM HARMFUL DISEASES. [Despite killing and maiming millions of people since the mid-1700s.]
- CLIMATE CHANGE ALARMISM IS TRUE. [No, everything in this narrative is a lie.]

We could go on and on. All the propaganda messages of the cabal are pumped into populations every day. The irrational, anti-traditional, anti-British and even insane tropes become accepted over time by gradual attrition.

#### JESUS AS A HISTORICAL PERSON

Now there was about this time Jesus, a wise man, if it be lawful to call him a man; for he was a doer of wonderful works, a teacher of such men as receive the truth with pleasure. #### **The result of this**

The net result is that people in high-levels of power are often corrupt, stupid and bought by some higher power to achieve certain ends. They fully endorse the propaganda of the cabal or they would not be given power.

A classic example of this pathetic type is Matt Hancock. A more useless and foolish politician is hard to imagine. It is a mystery to everyone that such a fool could rise to be a Secretary of State (this alone explains why Parliament is in decay). The release of his WhatsApp messages by Isobel Oakeshot reveals just how stupid, vainglorious, narcissistic and proud he is. He was not only useless and unqualified in his job at a vital time in history, he was wicked and following a higher agenda so that he knowingly put sick people into care homes whereby many needlessly died. He was also allegedly guilty of fraud, handing contracts to friends and relatives and also broke his own social distancing rules when common people could not even see dying relatives. This man is not just stupid; he is evil. His messages show that he was bought and paid for by Bill Gates.

### **But there are much more powerful, intelligent, controlling people above national executives**

It is folly to think that such insignificant people as Matt Hancock are really in charge of what is going on in Britain. There is a secret cabal of much more powerful leaders that dominate all Western governments.

#### **Corporatists**

Below the top people are groups of corporatists. Col. Douglas Macgregor says that the people that dominate America are not politicians in Washington DC but BlackRock, Raytheon and the pharmaceuticals. In other words, 1) top bankers, financiers and corporatists plus 2) the military industrial complex, plus 3) Big Pharma. Certainly Big Pharma dominated the world during the Covid chaos and was Hancock's master.

## The Global Elite cabal

Above these corporate groups are the cabal (expressed in various groups and affiliations) that really dominate the world. These people are psychopaths, sociopaths and Luciferians. This is really why the world has gone mad – the plans of the cabal are so evil that they are difficult to conceive. The result is insanity on the ground.

It is hard for people fresh to this concept to understand that the real people in power over governments are psychopaths and are truly evil. They seek to rule a reshaped world and reduce the human population by 95%. However, until you recognise this fact that those in power seek to harm you, you will never understand anything about geo-politics or social destruction.

I will give a couple of examples of families in power.

### *The Rockefellers*

John D Rockefeller, the richest oil magnate in the late 19<sup>th</sup> century, believed that people like him were destined to rule the world because they had power and wealth. He actually said this out loud. So he initiated various plans to take control over the world piece by piece, with his offspring continuing the long-term plan.

- **MEDICINE.** He planned the take-over of all medicine after 1901 and this started to develop rapidly after his commission of the Flexner Report of 1910. Gradually he developed allopathic medicine, which was based on drugs derived from his petrochemical industry (making huge amounts of money from waste products) and the destruction of all other forms of medicine, such as herbal, naturopathy, nutritionists, holistic, Ayurvedic etc.
- **EDUCATION.** He planned the take-over of education, beginning with the control of history, after 1908. Gradually Socialists and hard Marxists gained control of the humanities and many other subjects in the Western world. Socialism now dominates Western universities and many schools. Much of the historical narratives taught to students is false.
- **PEOPLE AND RESOURCES.** His sons planned to take-over of the planet's resources through Climate Change alarmism and control of the world's population by using pandemic fears in 1956.

The strategies of the Rockefellers alone helps to understand many of the current insane problems facing the world today – but there are many more strategies. Note that this corruption began 120 years ago and has slowly accelerated. The Elite plan a long game.

### *The Rothschilds*

The Rothschilds planned to control the world over 300 years ago. This was rooted in the principles delineated in the Babylonian Talmud that dominates Ashkenazi Jews today but also the ruthlessness and vengeance that arises from their roots in the brutal Khazars.<sup>6</sup>

The Talmud (and its offspring the Kabbalah) drives ideas about world domination by Jews with Gentiles being slaves to every Jew. This is openly stated by many rabbis which I have delineated elsewhere. Their Khazarian roots drove their wickedness, brutality, hubris Luciferianism and hatred for Christianity and especially for Russia and Germany.

The detailed outworking of the plan for world domination began in 1776 when their agent Adam Weishaupt founded the Perfectionists, later the Illuminati. This was the joining of

Jesuit control with Ashkenazi control and led to the take-over of Freemasonry and the implementation of many projects, such as the French Revolution and the accession of Napoleon followed by WWI, the Bolshevik Revolution and WWII.

The great riches that the Rothschilds had accrued from loans and usury (especially after the Battle of Waterloo), and funding both sides in all wars, allowed them to have vast power over nation states that always need money. Gradually Western monarchies, and then governments, were subverted and the money system of Western nations controlled through central banks owned by them, such as the US Federal Reserve and the Swiss Bank for International Settlements. The Rothschilds thus control many nations in secret. You can see a photograph of Jacob Rothschild prodding and glaring at a frightened Prince Charles. The original promise of Palestine as a homeland for Jews was made by Lord Balfour to Baron Rothschild.

Thus national governments, mad as they may be, are not the people in full control. They are dominated by elite corporations and bankers but controlling these are the cabal of really elite individual families.

However, the real power above them all is another matter.

## **The top level of control - Satanic insanity**

### **God's attributes**

We must first understand the character of God. God is infinitely holy and eternally perfect in all his attributes. We could make a long list of these attributes, such as: wisdom, goodness, righteousness, power, omniscience, omnipresence, and so on.

For our purposes here, God is sane. God is infinite in his wisdom and intellect. He is all wise, all knowing; nothing is beyond his comprehension. He knows the end from the beginning. God is the perfection of intellect. God is pure in his thinking.

Thus the servants of God are also to be pure in thought, of a sound mind; intellectually righteous. Saints must use their minds effectively. God demands this right thinking and warns about deception.

He stores up sound wisdom for the upright. Prov 2:7

God has not given us a spirit of fear, but of power and of love and of a sound mind. 2 Tim 1:7

Be transformed by the renewing of your mind, that you may prove what *is* that good and acceptable and perfect will of God. Rm 12:2

The eyes of your understanding being enlightened. Eph 1:18

We see this intellectual cogency being worked out in church history. During the Dark Ages, under the control of Romanism, people were superstitious, frightened and kept in the dark about truth. When the Reformation gave the word of God free reign amongst the people, with available vernacular translations, the power of the intellect began to thrive. The Reformation produced centuries of scientific discovery, inventive advances, and prosperity because the minds of men were released.

Godliness produces clear thinking and rationality.



## **Satan = Anti-God**

Satan seeks to reverse all God's works on the Earth. He intends to produce an empire under his total control that is the opposite of all God's attributes. This is why he seeks to destroy Christianity. As Satan gains more control through his proxies (the Elite cabal), good is replaced by evil but also right thinking is replaced by insanity. As mankind more and more reflects the image of Satan instead of God, so it becomes more insane.

The people in control of nations, under the control of Satan, thus bring in policies to centralise and aggregate power to them but a side-effect is to make people more dumb and more insane.

## **The repercussions of satanic control of world leaders results in insanity**

Much of this stems from the continual satanic temptation for leaders to believe that they are God due to the power that they wield over people. Anyone who seeks to rule the world is insane.

### *Nimrod*

Nimrod was the first empire builder after the flood establishing Old Babylonia as a kingdom before Akkad. This is reflected in the Tower of Babel where God intervened to stop the development of mankind in rebellion.

Nimrod was also the first king to deify himself, identifying as the sun god; a common thread in history. This was the model for Baal, (Bel), Merodach, Molech and other gods. His wife, Semiramis, became the moon goddess and the model for Astarte.

This example paved the way for future kings and emperors to proclaim that they were a god. It set the principle that not only does absolute power corrupt absolutely, it also engenders the belief in many such leaders that they are God, or God-like.

### *Nebuchadnezzar*

'Let his heart be changed from *that of a man*, Let him be given the heart of a beast, And let seven times pass over him. This decision *is* by the decree of the watchers, And the sentence by the word of the holy ones, In order that the living may know That the Most High rules in the kingdom of men, Gives it to whomever He will, And sets over it the lowest of men.' ... this is the interpretation, O king, and this is the decree of the Most High, which has come upon my lord the king: They shall drive you from men, your dwelling shall be with the beasts of the field, and they shall make you eat grass like oxen. They shall wet you with the dew of heaven, and seven times shall pass over you, till you know that the Most High rules in the kingdom of men, and gives it to whomever He chooses. ... All *this* came upon King Nebuchadnezzar. At the end of the twelve months he was walking about the royal palace of Babylon. The king spoke, saying, 'Is not this great Babylon, that I have built for a royal dwelling by my mighty power and for the honour of my majesty?' While the word *was still* in the king's mouth, a voice fell from heaven: 'King Nebuchadnezzar, to you it is spoken: the kingdom has departed from you! And they shall drive you from men, and your dwelling *shall be* with the beasts of the field. They shall make you eat grass like oxen; and seven times shall pass over you, until you know that the Most High rules in the kingdom of men, and gives it to whomever He chooses.' That very hour the word was fulfilled concerning Nebuchadnezzar; he was driven from men and ate grass like oxen; his body was wet with the dew of heaven till his hair had grown like eagles' *feathers* and his nails like birds' *claws*. Dan 4:16-17, 24-25, 28-33

Nebuchadnezzar had been a very successful emperor who built up Babylon to be a world power superseding that of Assyria (which his father, Nabopolassar had laid in ruins). He built the Hanging Gardens, one of the Seven Wonders of the World. He built canals,

reservoirs, roads and rebuilt temples and cities. He was the greatest and most powerful of all the Babylonian kings. Nine tenths of the bricks that survive from Babylonian ruins contain his name.

All this contributed to his pride, which swelled up in rebellion against God – who had granted Nebuchadnezzar power and ability. Basking in his greatness, God judged him with lycanthropy, whereby he acted like a wolf for seven years. However, at the end of this time he was truly repentant and appears to have become a true believer in God.

And at the end of the time I, Nebuchadnezzar, lifted my eyes to heaven, and my understanding returned to me; and I blessed the Most High and praised and honoured Him who lives forever: For His dominion *is* an everlasting dominion, And His kingdom *is* from generation to generation. All the inhabitants of the earth *are* reputed as nothing; He does according to His will in the army of heaven And *among* the inhabitants of the earth. No one can restrain His hand Or say to Him, 'What have You done?' Dan 4:34-35

### *Herod Agrippa I*

So on a set day Herod, arrayed in royal apparel, sat on his throne and gave an oration to them. And the people kept shouting, 'The voice of a god and not of a man!' Then immediately an angel of the Lord struck him, because he did not give glory to God. And he was eaten by worms and died. Acts 12:21-23

This was the grandson of Herod the Great who ruled for three years; the last Herod to be king.<sup>7</sup>

He was hailed as a god and lapped this up in vanity instead of denying it with humility. He was smitten, like Antiochus Epiphanes, with an intestinal malaise producing parasitic worms eating the rotting flesh. Josephus tells us that his prolonged death pangs lasted five days.<sup>8</sup>

### **The point**

We could go on. The Pharaohs were treated as gods. Alexander the Great was hailed as a god. In India certain leaders were considered as incarnations of Vishnu.

The point is that when men get great earthly power they tend to think that they have god-like attributes or are actually a god. Thus the Roman emperors after Augustus (Octavianus) initiated emperor worship. Power was the only reason for this; men like Nero or Caligula had no personal qualifications to even be in leadership.

Throughout history kings and rulers have tried to deify themselves or force this upon their subjects. It is a form of insanity to think that a mere man could be God.

The ruling Elite cabal thinks the same way; they truly believe that they have god-like powers given to them by Lucifer the light-bringer. We shall see later in 'transhumanism' that they say this publicly, mistaking technological advances with god-like power. Their strategies to control whole populations leads them to believe that they are gods.

Thus acting like they are a god seals their fate as truly insane.

## The introduction of mad policies to gain societal control but also make people do insane things

A full analysis of this would be a very long list. Almost everything the Elite cabal does tends to make people more stupid and insane as they comply with insane instructions. Such things include:

### **Covid regulations**

All the Covid-19 regulations and laws which were based on lies. Such as:

- Viruses can only travel a couple of feet, so social distancing of six feet is safe. No they can travel miles.
- Facemasks protect you from airborne viruses. No they are utterly useless but they do cause serious medical harms to wearers.
- Sterilising hands and surfaces protect you from an airborne virus. Please! You must be joking. Spirit-based cleansers damage the skin and can lead to cancer.
- Asymptomatic transmission; i.e. you can be healthy but still kill granny. No; this was a lie.
- Covid vaccines are safe, effective, stop infection and transmission. All these proved to be false. The vaccines are now killing far more people than died of so-called Covid-19.

Somehow, this insane reversal of epidemiological facts captured the British population, who willingly, but stupidly, complied. Actually it was the generation of fear that made a terrified citizenry submit to coercion.

### **Vaccines**

Think about this. You are told to believe that injecting toxic material and bacteria, mercury, formaldehyde, aluminium, anti-freeze, rabbit brains, carcinogens, monkey cells, pig faeces, cells from aborted and murdered babies, pig blood, and much else, under the skin (the first line of defence of the immune system) into the muscle or bloodstream is good for you and will give immune protection. It's just too stupid to even think about. There is no safe level of aluminium and mercury that can be injected into people.

Every vaccine has caused multiple harms and killed certain people since the mid-1700s. Vaccines are definitely linked to modern diseases such as Autism and SIDS. It is a fact that, the world over, unvaccinated kids are far healthier than vaccinated Western kids. Amish children have no cancer, no diabetes and no Autism – because they never have any vaccinations. The basis of inoculations is insane.

### *GM insects utilised to vaccinate people*

Yes, this is happening now. Bill Gates' GM mosquitoes have caused a malaria epidemic in the US. Gates has admitted this. This policy is insane.

### **Gender issues**

- Introduction of 'Queer Theory'<sup>9</sup> into school curricula. This is insane.
- Introducing gender-neutral toilets in schools whereupon young girls get assaulted by transgender boys and other girls are too afraid to use the toilet all day. Head-teachers allowing this are insane.
- A Sussex teacher calling a young pupil 'despicable' for not agreeing to recognise a girl pupil who self-identified as a cat. This teacher is insane.

## Sex education

- The UN demanding that young kids should have sexual partners. Sexualisation of children from the age of four. Encouraging kids to touch each other in the classroom.
- Teaching kids about graphic sexuality from the age of three.
- Teaching kids about oral sex, anal sex, and sexual positions aged six.
- Encouraging 6-year olds to transition (transgender) without parental consent. Arranging for hormone treatment of such.
- School textbooks showing extreme pornography. Grooming kids into pornography.
- Children having to go to mental health therapy as a result of sex education at school. Kids becoming withdrawn, depressed and anxious after sex education lessons.

All of these things are absolutely insane and educationalists allowing this should be prosecuted for child abuse.

## Food issues

- Eating insects. The chitin<sup>10</sup> in these causes medical harms. The heads of Welsh schools that have already introduced this should be prosecuted.
- Castigating healthy fat, such as butter, coconut oil and rendered animal fat, and replacing them with seed oils which cause inflammation and disease.
- Denouncing saturated fat in meat but replacing it with High Fructose Corn Syrup and trans fats, which are a serious cause of cancer and other diseases.
- Drinking water from sewage waste. [Getting the message yet!]
- GM food. This causes multiple medical harms, apart from the toxic nature of glyphosate (herbicide) in the food. 90% of Americans now test positive for glyphosate.
- 13 nations have agreed a programme of food production reductions and eradicating farms to create food scarcity to be more Green.

## Media issues

### *Believing lying propaganda, such as false history*

Almost everything students have been taught about leading issues are lies, such as the American Civil War, the Boer War, WWI, WWII, the Bolshevik Revolution, The Holocaust, Mao's Revolution, the Cold War, the Vietnam War, the Iraq War, The Syrian insurrection, the Ukraine conflict etc. The media undergirds this all the time.

Almost everything in the mainstream media is a false construct or outright lies and should not be trusted. For example, the reporting of the Ukraine conflict is completely false in almost every respect. The whole narrative is a lie. This was also true of the Syrian insurrection where the BBC has now been banned from entering for continual false reporting over years

## Entertainment

- Disney have produced a new show called 'Praise Petey' featuring a young girl who inherits a human-sacrificing, blood-drinking cult whose logo includes the all-seeing eye. Really!
- Famous stars of recent Hollywood movies have been openly accused of child sexual abuse, grievous bodily harm, kidnapping, sexual abuse, drug abuse and more.

### **Climate alarmism**

- There is no scientific evidence that atmospheric CO<sub>2</sub> controls global temperature.
- Net Zero CO<sub>2</sub> emissions are impossible since every human being breathes it out.
- CO<sub>2</sub> is actually a wonderful, miracle gas that gives life to plants and thus creates oxygen. Making it the enemy of the planet is insane.
- Termites produce more greenhouse gases than mankind.
- Volcanoes produce more CO<sub>2</sub> than mankind.
- Demanding that cows wear face masks to save the planet from exploding is insane.
- Low Traffic Neighbourhoods.
- 15-minute cities.
- Killing millions of cattle and chickens on false Climate Change pretences to initiate food scarcity.
- Destroying thousands of farms, e.g. in The Netherlands, to reduce nitrogen emissions.
- Diminishing farms and rewilding farms in Britain to reduce food production.
- Getting rid of efficient, cheap, clean power stations, such as coal (with new filtration systems) and nuclear and replacing these with inefficient, costly non-sustainable wind turbines and solar panels. [NB turbines stop working or collapse when it is too windy or not windy enough and only last a maximum of ten years, but often collapse before then and require costly maintenance all the time using oil. Solar panels have been completely smashed by hailstones but don't work if there is no sunshine. These produce as little as 3% of the national power needs.]
- The UN (controlled by the Rockefeller Club of Rome) introducing impossible sustainability goals as a front for taking complete control over the world's population in a Socialist system of governance.

- The government using militarised applied psychology to create fear during Covid or to promote propaganda for coercion.<sup>11</sup> Using the 77<sup>th</sup> Brigade of the Army to target the domestic population instead of a foreign enemy.
- People arrested for mis-gendering people or misusing gender pronouns.

### Education

The indoctrination of children and teenagers to mould the thinking of students into compliance with Elite strategies.

These are the chief lies burned into the minds of kids.

- *Socialism*. This includes demonising Right Wing views as racist, sexist, and chauvinistic. Left Wing ideas are progressive and liberal; Right Wing ideology is regressive, suppressive and fascist.
- *Climate alarmism*. This literally scares young people to believe that the Earth will burn up within seven years.
- *Evolution*. Dehumanises people into mere animals.
- *Atheism*. The denial of God. This undergirds all Elite policies.
- *Humanism and Transhumanism*. The elevation of man.
- *Critical Race Theory*. White people are racist and evil.
- *Intersectionality*. Fragmentation of society into victim groups.
- *Feminism*. Today radical Feminism is misandry.<sup>12</sup>
- *Sexualisation*. Denial of childhood. Sacrifice of kids.
- *Queer Theory*. Denial of the traditional norms about sex.
- *Transgenderism*. People can decide their sex, species and identity at will.

### Government issues

- Appointing Gay priests and bishops.
- Appointing female priests and bishops.
- An Archbishop of Canterbury that was also a Druid priest.
- A prospective pope that was an overt Satanist.

### Medical issues

- Creating cigarettes which contain 200 chemicals including arsenic (which causes cancer) and pyrazine (which creates addiction) to deliberately kill people. Hiding this by demonising nicotine – which is found in many vegetables and is very healthy, even preventing virus infections. For many years doctors promoted the health benefits of smoking cigarettes, even on the cover of Time magazine.
- Creating the AIDS panic when it was the drugs used for treatment (e.g. AZT)<sup>13</sup> that killed 300,000 mostly Gay people.<sup>14</sup>
- Using chemotherapy to treat cancer when it fails 97% of the time and ruins the immune system.
- Killing elderly patients on the Liverpool Care Pathway.
- Using Remdesivir, Midazolam, ventilators and Morphine to treat Covid patients, which killed them.
- Moving sick patients into vulnerable care homes causing a local epidemic killing people.

### War

#### *Defending the Ukraine government*

Ukraine is the most iniquitous on Earth.

- It is taking organs from wounded soldiers for trafficking according to testimonies from Ukrainian soldiers.
- It is a world centre of illegal organ trafficking and has been for many years.
- It trafficks children as sex slaves.
- It is a world centre of money laundering; especially on behalf of America.
- It is a centre for US illegal bioweapons development.
- It has closed down all opposing newspapers, TV channels and political parties. It then shut down elections completely.
- It has assassinated critical journalists.
- It has staged massacres. Once it burned 45 people to death in public.
- It has posted videos of tortured Russian prisoners of war before they were shot (including castration, kneecapping and eyes gouged out).
- It engaged in genocide for eight years against the Donbass (thus provoking the conflict with Russia). Ukraine started this war by shelling civilians!
- It banned the speaking of other national languages (there are many) than Ukrainian
- It shoots deserting Ukrainian soldiers fleeing certain death by Russian artillery.
- It provides no family benefits for many soldiers killed in the war.
- It has staged false flag terrorist operations.
- It is shelling a nuclear power plant defended by Russians but blaming Russia.
- It is led by a literal comedian who is a cocaine addict and embezzler.<sup>15</sup>
- It is home to genuine Nazi military groups (e.g. Azov battalion) that have power over the government.

- It is a puppet of the CIA and Jewish oligarchs (such as Molinoisky).
- It was about to use illegal depleted uranium shells supplied by Britain until they were destroyed by Russia.
- It is now proposing to utilise widely banned cluster bombs which will multiply civilian casualties.

Let us take some specific examples in more detail.

### **Mobility**

Mobility is one of the most useful tools to power society, allowing citizens to travel widely. This has multiple advantages including allowing people to travel long distances to get a better job.

For centuries the poor and the middle class never had vacations. Holidays were 'holy-days' whereby there would be local feasting, drinking and dancing in the community and no one would work that day. There were dozens of these one-day festivals. People stayed in their local community and rarely travelled more than a few miles, such as to market or to buy animals. The only people who travelled, especially overseas, were aristocrats who had the money to do so.

This changed in the mid-20<sup>th</sup> century when summer holidays became available for working class people. Mobility created by better transport enabled poor people to get to British seaside towns. Then, in the 50s, Billy Butlin created the holiday camp allowing families to stay in cheap chalet accommodation (hotels were too expensive). A few decades later and cheap air travel enabled even working class Britons to fly to Europe for cheap holidays. In fact foreign holidays became cheaper than staying in Britain. In the 90s, a week in Greece could cost less than £200 including airfare when that would only cover one or two nights in a British hotel.

The car allowed Britain huge amounts of choice. This not only covered vacations and day-trips, providing much needed rest away from hard work, but also allowed commuting to open up better work opportunities. Railways also provided good commuter services, but these are not as flexible as car trips (especially if you have no railway station).

Cars also allowed families to move location for better work while still allowing ease of visiting needy relatives on a regular basis. For many people cars were necessary to drive some distance to supermarkets to buy food when there were no local outlets. In rural areas cars are vital since the bus availability is shockingly poor.

We could continue. Mobility, especially in cars, has proved to be a boon in the modern world.

Yet the powers that be have now declared war on cars. This is being daily worked out in the actions of local councils. The government is even demanding an end to petrol / diesel cars by 2050 (no new ones after 2030) in obedience to precepts issued by the UN. This is going to have a terrible degrading effect on social mobility if it ever goes through. The idea of electric vehicles replacing petrol cars is now a running joke. I have explained this many times. Green policies hate cars. And yet Green councils thrive on massive taxes placed on cars through taxation, parking fees, and various regulations. The Greens despise cars but live off their taxation.

The hypocrisy of the EV dogma is off the scale.



- The batteries require child slave labour in developing nations. The open cast mining for lithium and cobalt demands huge amounts of water and removes many tons of toxic waste earth and leaves deep scars in the local geography. The mining for cobalt and lithium requires massive dumping of waste on land areas.
- The batteries only last a maximum of ten years, often less and cost over £20,000 to replace. They are a Green nightmare.
- Batteries are so heavy that they damage bridges, car parks and roads.
- The heavy batteries cause EV tyres to create far more pollution than the tyres of petrol cars.
- The batteries routinely explode due to ‘thermal runaway’ whereby batteries release temperatures up to 400 degrees C. Insurance companies will not insure your car if it has a ding, because this triggers a later explosion. EV explosions have killed many people worldwide and have even sunk a cargo ship and burned down whole buildings. Any slight damage to the battery housing or battery (e.g. from mounting a kerb) will result in a later explosion. Repairs to these require quarantine of the vehicle 15 metres away from anything and special technical expertise, according to government guidelines. This will increase insurance payments. Battery fires cannot be extinguished by water or foam and continue ejecting flammable material like rockets. All lithium appliances (cell-phones, lap-tops, tablets) have the propensity to explode if the battery is overcharged or damaged and should never be left unattended.
- EVs are very expensive.
- There is not enough power in the grid to charge EVs for the whole population.
- Many people cannot charge EVs from their house.
- There are insufficient charging posts on the road system and these are now diminishing due to energy costs.
- EVs have a much greater reduction of re-sale value (depreciation) than petrol cars. For a two-year old Volkswagen mid range EV the depreciation was 50%.
- EVs cost more to repair, and take longer to repair, than petrol cars.
- Taken as a whole, the creation of an EV creates more CO<sub>2</sub> emissions than an ordinary car.

15-minute cities will restrict the movement of cars making them drive further to go locally, waste energy and cause more pollution (such is the insanity of the Greens). LTN’s do exactly the same thing, cutting off roads with huge planters and barriers for no reason other than to hurt drivers.

The establishment attack on cars and mobility is insane; it makes no sense. It worsens civilisation. It makes life worse for the poor. It costs more money. It requires more energy. It causes more pollution. It requires child slave labour. It creates more CO<sub>2</sub>. It causes more threats to life through explosions. The policy is insane.

### **The stupidity of wind farms**

People are now fed up with the costly and inefficient wind turbines; the narrative is finished. I’ve written extensively on this; here just some simple points.

- Taken in its entirety of supply, manufacture and installation, a wind turbine creates more CO<sub>2</sub> than a nuclear power station or a properly filtered coal-fired power station.
- Turbines only last for a maximum of ten years, often less.
- The unsubsidised cost of supply, manufacture, installation, maintenance and eventual removal is far greater, per kilowatt-hour of energy produced, than any other form of energy production. Getting rid of expired turbines is in a landfill site.
- The cost of maintenance alone is prohibitive and huge. Offshore maintenance costs are even greater. Huge amounts of oil are used to make the turbines work.

- Some aspects of manufacture are not sustainable, such as rare earth minerals used, masses of concrete for the base, steel production etc.
- Many turbines have collapsed in strong winds or rusted away and fallen apart. Some have exploded and caught fire.
- Turbines do not work when it is too windy (there is a shut down mechanism to stop the turbine collapsing under pressure) or not windy enough.
- The turbine blades kill millions of insects, bats and birds – especially larger protected bird species like raptors.
- Energy production can be as low as 3% of the national requirement.
- Countries, like Germany, that have trusted in sustainable energy production and closed down nuclear and coal plants are facing a winter energy catastrophe.

Only insane politicians could have sold this pup to the gullible public as it is a colossal waste of money and puts the nation into energy insecurity.

### **The Covid Chaos: a false narrative**

A simple summary of the insanity will suffice.

- There was no pandemic, Excess deaths in 2020 were fewer than every year before 2009. There are far more excess deaths now due to the vaccines (which have killed millions) but no fear and no lockdowns.
- Public Health Four Nations downgraded the virus to a non-serious not highly infectious disease on 19 March 2020.
- The government used militarised behavioural psychology to ramp up fear in the population which was unjustified.
- Lockdowns were introduced (e.g. 23 March 2020) after the peak of infections (e.g. 15 March) in every case.
- Lockdowns are the wrong policy to deal with an epidemic; this was understood before introduction. They were known to cause huge collateral damage in multiple areas and kill more people than the virus. More children died of suicide than Covid for example.
- It was known that facemasks were ineffective against an airborne virus but did cause many medical harms including cancer and bacterial pneumonia.
- Social distancing was pointless when an airborne virus can travel 23 miles.
- The Coronavirus laws were illegal under the British Constitution.

### **Covid vaccines**

Without long explanations of this subject (which I have done elsewhere) the contents of these vaccines are clearly insane and only psychopaths could have invented them. Here are just some of the contents.

- *PEG*. This is the nano lipid particle that envelops the spike protein to allow it to get into cells without being destroyed. This alone causes all sorts of medical damage, including triggering anaphylaxis in 30% of people.
- *The spike protein*. The insane claim is that the mRNA goes into the cells of the body which then become a spike protein factory creating the dangerous portion of SARS-Cov-2 to trigger the immune system to fight it. The spike protein goes into all the organs of the body despite a denial that this would happen. It has been observed during autopsies. No one has yet proved that this is a safe procedure and no one knows what the end result will be after months and years.
- *DNA contamination*. It has recently been discovered that the vaccines inevitably include portions of DNA in amounts that are highly dangerous to the body. Again no one is certain exactly what these will do to the body.

- *Snake venom*. It is alleged by many that the vaccines contain the venom of cobras and the Chinese Krait.
- *HIV DNA*. This has been observed in analysis of the vaccine.
- There are multiple other dangerous contents.

Only psychotic people would put such things into a syringe and inject them into people.

One of the clear results of these contaminants is huge blood clots. This is being observed in autopsies all over the world. As these clots hit the brain or the heart so they cause strokes and heart attacks. The world is currently seeing a massive spike in heart attacks, even amongst young, fit, healthy people and children.

Now the health regulators in America, Britain and the EU have all received huge amounts of data of adverse reactions to the vaccines including fatalities in unprecedented numbers. There are more reports for the Covid vaccines than for all vaccines added together in the last 30 years. Yet no one is doing anything about it. The vaccines should have been pulled two years ago but are still being pushed. This is insane. Only mad people would continue this roll out that is killing huge numbers of people.

### **Implications of Climate Alarmism**

There is no climate catastrophe. The claims are based upon sheer lies, false statistics, fabricated temperature gauges,<sup>16</sup> and flawed computer modelling by the IPCC.<sup>17</sup> No one has proved that CO<sub>2</sub> drives global temperature rises. These facts have been proved by specialists over and over again but are not reported in the media. The huge consensus of scientists is opposed to climate alarmism not for it, but these are silenced and shut down.

None of the claimed crises are happening. Polar bears are thriving and need to be culled. The Great Barrier Reef is thriving. Ice sheets are expanding. Deaths caused by climate events are at an all-time low. The air in London is cleaner than at any time in history. Tuvalu and the Maldives did not sink as claimed years ago by the UN but have expanded. Wildfires and Atlantic hurricanes are reduced in number than average over the last 100 years. Global temperature has stalled for eight years and since 1995 it has got colder apart from a few natural warm blips (e.g. two El Ninos). Some countries have seen their coldest winters on record in recent years. Etc. etc.

Despite this, insane policies are being enacted.

- Eating meat is demonised as contributing to Climate Change due to cattle flatulence.
- 200,000 cattle are to be killed in Ireland to control Climate Change. [This is really about creating food scarcity.]
- 90% of Dutch farms are to be destroyed to make way for a megalopolis headquarters of the cabal. Also to create food scarcity. The excuse is that nitrogen (in fertiliser) causes climate warming.
- Cattle are to wear facemasks.
- Over 120 food processing plants world wide have been destroyed within months of each other.

- ULEZ schemes are to be introduced in Greater London costing people an additional £12.50 per day to get to work. This is to clean the air, which is already cleaner than ever before in history (based on statistics since 1700).<sup>18</sup>
- Net-Zero policies. [Banning gas cookers. Stopping new petrol / diesel car production by 2030. Banning petrol cars after 2050. Banning gas and oil central heating. Stopping cement, glass and steel production. Stopping shipping. Stopping commercial aircraft. Only using inefficient wind and solar power for energy. Only using EVs. Only purchasing three new items of clothing per year. Creating 15-minute cities and LTN schemes to hinder traffic flows. See elsewhere in this paper on EVs and wind farms.]
- Making the poor much poorer. E.g. by demanding heat pumps (costing £30,000 or more depending on the house construction). Demanding expensive, useless EVs. Demanding electric cookers. Demanding home insulation. ULEZ schemes. LTN schemes causing longer car journeys. Increased energy costs. Green subsidies on energy bills (about 24% in UK). Green levies on energy bills, e.g. a new £120 additional cost this year in UK to cover the cost of suppliers going bust. Inflation: worsened by climate policies, which increase energy costs; e.g. subsidising wind farms.

### **Sponsoring Pride**

This is now out of control. Even construction firms feel the need to erect a Pride flag on building sites. Bank frontages are adorned with the Pride rainbow. Police cars have the pride colours. ## Examples of the insanity planned for us

### **Megalopolis cities / forbidden access to the countryside**

This is outlined in the UN's Agenda 2030 plan for mankind.

Human populations are to be concentrated into large cities filled with high rise apartment blocks. Some cities are to be long strips of land. Corridors between cities will allow communication. However, outside of these cities is wild countryside forbidden to city dwellers. Only federal authorities (the Elite) will be allowed access to nature.

### **5G**

As a necessary adjunct to the surveillance and control of people and appliances, 5G telecommunication is being rolled out everywhere on Earth. It is already fully operational in Australia, Wuhan (China) and Lithuania and several other countries where it has caused multiple medical problems (headaches, nausea, fits, insomnia, bleeding from the eyes and ears, respiratory issues, and cancer) which is usually blamed on Covid. 5G is incredibly dangerous.



5G masts and boosters have already been erected nationwide during the lockdowns while people were not watching. Masts were erected in every school and hospital for example. Booster stations and connections are still being established (hence road works). This also explains why urban trees are being chopped down which hinder the 5G signal. This programme is completely illegal. No health risk assessment was performed before this was rolled out and a risk assessment would demonstrate that it is incredibly dangerous.

We have known about the dangers of microwave radiation since the early 1930s. There are over 20,000 scientific papers explaining the dangers of non-ionising EMF radiation. This is not the place for a full explanation of this but non-ionising EMF radiation causes the water in cells to vibrate and heat up causing cell damage, DNA damage, multiple diseases and eventually cancer and death. If the wattage (power) is turned up 5G masts (which contain super-capacitors) become a death ray killing instantly. [The American Navy has an EMF radiation weapon that burns holes in ships.] Those that live near the main masts (tall poles with a wider section at the top) will be the first to suffer and die. In 5G tests in several nations all birds dropped to the ground dead when it was turned on.

### **Central Bank Digital Currency**

This will work alongside a Chinese-type social credit system and total surveillance containing facial recognition. There will be no physical money but only digital currency controlled by banks. This will mean that a bank could terminate or freeze your money at the flick of a button on a computer if you do not comply with social demands. For example, in China if you jaywalk or commit a minor misdemeanour, you will be fined automatically. For more serious offences your money is frozen for a week and so on.

Thus in a future lockdown (yes they are planned by the WHO) if you were caught not practising social distancing by facial recognition cameras, you will automatically be fined. If you were outside walking further than the stipulated distance, your account will be frozen or supermarkets and shops will not accept your account. If you question government policy actively your account could be completely terminated and you will be unable to buy food.

This is why cashless transactions are being actively encouraged in shops and service providers, or even for council car parking.

### **The destruction of the NHS**

The NHS is being destroyed in its present form, farmed out to private enterprise, and is now hopelessly inefficient (18<sup>th</sup> out of 19<sup>th</sup> amongst developed nations; *The Kings Fund*, 26 June 2023 report). Due to adopting Woke policies<sup>22</sup> and unwieldy bad NHS management, Britons are dying from avoidable causes in far greater numbers than ever in history. Britain is already the worst at stroke recovery, cancer recovery and heart attack recovery. But worse is yet to come; which I will itemise.

#### *The plans outlined*

The strategies are explained in the following documents: 'The NHS Long Term Workforce Plan' (June 2023)<sup>23</sup> and the 'NHS Long Term Plan' (January 2019). These propose the abolition of traditional hospitals completely.

- Hospital beds and wards will be greatly reduced.
- There will be no guaranteed hospital treatment for all conditions except five (strokes, heart attacks, sepsis, anaphylaxis and major trauma).
- Treatment will usually be by community hubs or at home (Integrated Care Systems).
- A third of outpatient appointments will be avoided [despite an increasing population!].
- Those that need hospital care (emergency conditions) are treated with 'same day emergency care' without any overnight stay [how?].
- Inpatients are to be avoided wherever possible.
- Community urgent treatment centres will replace A and E.
- Digital access to services becomes widespread.
- Smaller acute hospitals will be built for rural patients.

### *Budgets*

- Budgetary efficiencies [try not to laugh] will drive better investment in technology.
- There will be a personal health budget. [What happens when the limit is reached?]
- Budgets will be wasted on the Equality, Diversity and Inclusion plans in the most diverse institution in the world. Meetings will be conducted to discuss the wellbeing of staff. Plans to develop a clear employee value proposition will be promoted. The NHS Health and Wellbeing Framework will have ongoing reviews. Meanwhile the NHS makes staff work on 12-hour shifts, six days a week, whereby fatigue results in causing damage to patients.<sup>24</sup>

### *Digital technology*

- AI and robots will perform many treatments. Technological innovations will include: speech recognition, robotic process automation, remote monitoring [requiring in-body surveillance] and AI. [So you will be sick at home, then be diagnosed by AI and algorithms (for which you need a computer or Smartphone), then treated by a robot, then monitored remotely (perhaps many miles away). Hard luck if you suddenly develop complications requiring immediate assistance.]
- There will be virtual wards controlled by robots and AI. Primary and outpatient care will be digitally enabled. [What does that mean?]
- AI will be used for: diagnostic support (including ophthalmology and radiology); clinical decision making; administrative automation; predictive health analytics; patient triage; preventative healthcare; drug discovery and design; data analysis.
- Robotics will be used for: robotic assisted surgery; automated dispensing; administrative processes; increased operational capacity and speed; transformation of service delivery.
- Remote monitoring results in: distant diagnosis by AI; care decisions; detection of escalation of a condition; blood pressure readings and oximetry; managing cardiac and respiratory disease.
- Expansion of the Virtual Hybrid Learning Faculty. [A very poor form of training.]
- People with long term conditions will be cared for by inter-operable data, mobile monitoring devices and connected home technology.
- The digital leadership of the NHS (!) will be enhanced by the NHS Digital Academy programme. Digital leadership will be on every NHS board.
- All providers will be expected to advance to a core level of digitisation by 2024.
- Patient data (depersonalised) will be shared with industry to make innovations.
- The whole workforce must become digitally competent.

### *Genomics*

- There will be a special target on genomics.
- The new Genomic Medicine Service will sequence 500,000 whole genomes by 2023/24. [Data is highly valuable and can be sold at high cost to private enterprises.]
- Test bed clusters will be introduced from 2020.
- Genomic innovations will be accelerated through a new Medtech funding mandate. These will then be exported globally.

### *Primary care*

- GP surgeries (as they are now) will be terminated. The divide between primary and community health services will be dissolved. New contracts will be issued.

- Pharmacies will prescribe drugs and make diagnoses.
- GPs will be part of community hubs; current GP practices will be forced to work together and extend the range of services (Integrated Care Systems). There will be a range of staff including: GPs, specialist doctors, pharmacists, district nurses, community geriatricians, dementia workers, and AHPs (e.g. physiotherapists).
- Doctors other than GPs will work in primary care.
- There will be on-line digital GP consultations. Further diagnoses will be by AI.
- Initial treatment will be at a patient's home.
- Volunteers will bolster practices.

### *The MHRA*

- The MHRA ceases to be a medical regulator and becomes a global Big Pharma enabler (according to CEO June Raine). Pharma funds 86% of the MHRA already.

### *Ambulances*

- Patients will be treated by paramedics at home or taken to a hub but not a hospital.
- Hand-over delays will be eliminated. [Since this was written in 2019 these are now much worse than ever before. Ambulances are stuck in hospital car parks for hours or even days.]

### *Staff*

- Medical workers will receive less training; especially direct recruits with a certain experience. Medical workers will need to become experts in digital technology. Nurses will be forced to become more flexible and more IT savvy. Current teams and care institutions will be broken up. Flexible teams will work across primary care and local hospitals.
- There will be a shift from a dominance of highly specialised roles to a better balance with more generalist ones.
- There will be electronic rosters and e-job plans.

### *WEF Flagship Report: 'The Top Ten Emerging Technologies', June 2023*

This shows the new technologies that will impact medicine in the near future.

- SMART clothes and personal appliances linked to medical care.
- Generative artificial intelligence. Machine learning used to develop drugs.
- Designer phages (viruses invading bacteria).<sup>25</sup> It reprograms phages and redesigns our micro-biomes.
- The metaverse will be used to treat people with mental health problems. There are multiple metaverses in which people interact.
- Spatial-omics: slicing brains to investigate cellular architecture.
- Flexible neural electronics. Rewiring people by using circuits to interface with our nervous systems. Machines will have their own thoughts and will be used, for example, in prosthetic limbs.
- AI facilitated health care. Using more AI in health care to anticipate future pandemics.

### *Comments*

These reports, written by committees, are pie in the sky thinking and not based on common sense or human experience. They trust that digital services will work fine and never break down. What happens in long-term power cuts (predicted for next winter due

to energy shortages)? What happens when lithium batteries (which will be everywhere) explode?

Will patients stand for a robot performing surgery on them? Will old people with no computer be 'enabled' by a virtual ward and AI diagnosis? When blood test appointments went digital the ability to get a blood test worsened. The on-line system would fail. People without computers found that the 'phone number was never answered and could not get appointments at all. Accessing the system was more complex than simply 'phoning for an appointment as before. So people just turned up and overwhelmed the facilities, such as 40 people arriving at once.

What about respiratory patients? These cannot be dismissed in one day. How can severe respiratory cases be dismissed and go home?

How will primary care interactive hubs save time and money? Surely they will cost more. There will always be the same amount of medical care required and setting up new systems to cater for this same care will certainly cost more money. Unless these hubs are being set up to be privatised? Umm!

They claim to save millions of pounds; but like every other reform claiming to save money, they will end up costing more than today. All new IT systems end up costing more money. The last major NHS national IT reform under Tony Blair was scrapped after spending billions on it.

Focusing more work on community hubs based on GP practices is risky since GPs are retiring early and new GPs are often working part-time. Who will control all this new work? Will a new management system be necessary for this multi-disciplinary platform? This is not budgeted as far as I can see. Integrated Care Systems will have a regional director, which will mean a new NHS department. This is increasing over-bloated NHS administration even further.

The expectation to keep nearly all medical conditions out of inpatient care in hospitals is a forlorn hope. Experience shows that this is highly unlikely.

Since the Long Term Plan was published in 2019 NHS performance has collapsed. There is a 7.4 million waiting list. Ambulance response times are the worst ever. Recovery of key conditions is the worst in the developed world despite more than adequate spending (about mid-range within Europe, while other nations have a better record).<sup>26</sup> Staffing is still inadequate with 40,000 nurse vacancies. Doctors are not much better. Crises abound and malfeasance cases hit the headlines. Cancer cases are reaching an unprecedented crisis according to Dr Karol Sikora (leading oncologist). This is despite the massive promises of better cancer care by now in the document. The measured health of Britons is at its lowest ebb. Staff disgruntlement is exemplified by unprecedented strikes of consultants, doctors and nurses. Yet management continues to grow with Woke non-jobs wasting millions every year. Much of the NHS is privatised with each sold section performing worse than when it was nationalised (e.g. the private Patient Transport service and what was the Blood Transfusion Service, now owned by an American hedge fund).

Every metric analysing hospital care was loudly predicted to be better by now (4 years after the Long Term Plan was published) but is actually far worse. Whether it is mental health cases, heart disease, strokes, young suicides, or maternity issues, every metric is far worse

than in 2019. The plan is an utter failure thus far. Why should its future plans be any better?

The long-term plans are mere wishful thinking and a waste of money. But no doubt they will try to be initiated.

Genomics and artificial intelligence (AI) in particular will transform our ability to prevent disease, treat and manage disease, supporting a shift towards better prevention of disease and more personalised care outside hospital.

To deliver the benefits of these [technological] advances, we need to upskill the workforce with core skills and increase the number of expert roles across digital, genomics.

Upskilling the workforce is the key to unlocking the potential of science, research and technology to deliver the care of the future.

In future, all newly qualified pharmacists will be independent prescribers.

NHS Long Term Workforce Plan.

New diagnostic and treatment practices allow patients to spend just hours in hospital rather than being admitted to a ward. [Ed. What practices? How will a certain practice stop a chronically ill patient being admitted?]

Under this long term plan, every acute hospital with a type 1 A&E department will move to a comprehensive model of same day emergency care. [Ed. If this were possible, why is it not being done now? Is it because it is impossible?]

Under this long term plan, digital-first primary care will become a new option for every patient improving fast access to convenient primary care.

Outpatient services will be fundamentally redesigned. ... We will therefore redesign services so that over the next five years patients will be able to avoid up to a third of face-to-face outpatient visits, removing the need for up to 40 million outpatient visits a year. [Ed. Will patients trust the diagnosis of a robot or a digital algorithm? Will AI see the medical signs in a person's eyes, gait, mood, demeanour, skin, pallor etc.]

## **The sacrificial lambs**

This insane rollout of plans to wreck society and control the people has immediate victims. Eventually, everybody under the Elite will be a slave but there are instant victims that are sacrificed to this evil agenda.

### **Children**

Throughout history, where satanic empires have held sway, child sacrifice was a primary feature of idolatrous religion. In Biblical ancient history this followed Baal / Molech worship and was evidenced in the Canaanite tribes and other surrounding nations. This continued in various ethnic groups in later history.

The idolatrous Luciferians in power are directly sacrificing children today through their various agendas. I will simply list a few of these without a deep dive.

### *Covid school closures*

Everything in the Covid chaos had a direct negative impact on the health and wellbeing of children. This was insane since children did not suffer from Covid at all; yet children bore the brunt of government actions in order to protect older people.

Closing schools was insane and pointless (Sweden did not close down most schools and had a better Covid excess death rate). This deprived a generation of kids an education and stability. Younger children suffered speech difficulties and development regression. Education standards have crashed. Hundreds of thousands of children never went back to school. Many children reliant upon school meals went hungry. The inability of teachers to notice bruises and inform Social Services meant that abused children suffered terribly and some were murdered.

### *Covid lockdowns*

The data is now in and what I said from the very beginning has been proved true. The lockdowns were the most damaging, scandalous, social repression in history. The scale of damage will be felt for generations. But ignoring the massive inflation, economic damage, business closures, damaging practices (e.g. work from home), dead old people and so on, the worst effects were experienced by children.

The psychological damage to children caused by loneliness, isolation, lack of social interaction, lack of purpose etc. is immeasurable. Report after report shows that a generation of children have suffered irreparable damage; their lives are irretrievably affected.

The worst example is suicides. More children died of suicide than of Covid. This single fact alone is sufficient to prosecute government ministers for malfeasance and corporate manslaughter. Less serious conditions include: vast increases in self harming, drug abuse, alcohol abuse, bulimia, anorexia, tics, anxiety, paranoia, schizophrenia, depression, manic depression, and more. This has occurred at a time when the NHS was least able to cope. In some instances, children are being sent hundreds of miles from their family to receive mental health treatment due to lack of local beds or are on a waiting list for months or years.

### *Covid vaccines*

This is a major scandal that requires prosecutions of those involved.

Children were at virtually no risk from Covid. Almost no child died from it and the very few deaths with Covid were due to prior serious conditions (co-morbidities). Yet vaccines were forced upon children as young as six months.

Now I have already explained that the Covid vaccines were not vaccines but gene treatment; were not properly tested and the trials showed that they were highly dangerous; were not formally authorised; and that early tests after rollout showed massive adverse reactions and deaths. The government knew that the vaccines were highly dangerous and caused fatalities; especially from heart disease. Despite this children were coerced into taking them. As a result untold thousands have died from heart disease; many falling dead on the playing field during sports. More have contracted myocarditis, which will likely kill them within five years. Others have suffered severe menstrual problems. Yet more have suffered a range of conditions including: blindness, deafness, neuropathy, gastro-intestinal issues, pericarditis, paralysis (there is a huge spike in Guillain Barre syndrome), limb amputations and more. This is confirmed in the MHRA yellow Card reporting system and in those of other nations (e.g. VAERS, EudraVigilance).

### *Kidnapping, sexual abuse and murder*

The child trafficking situation globally is becoming mainstream news after the recent movie, *The Sound of Freedom* (banned in many countries). I have been explaining this for many years. Reportedly, one million kids disappear every year worldwide; up to 100,000 in America alone.

The UN is also a facilitator of child abuse and prostitution wherever it has had a major influence. This has become mainstream news and the subject of a Hollywood movie. Ukraine is one of the world centres for child and sex trafficking.

For decades whistleblowers, retired policemen, retired lawyers, retired Social Workers and victims have alleged (with much evidence) that there is a high-level child abuse and murder ring in the establishment and especially in Westminster. MPs, Prime Ministers, judges, police chiefs, and celebrities have been accused and in every case senior officials closed down the investigation.

Care Homes have been accused of trafficking children for decades. In some cases investigations have developed and found evidence, even of child murder, but then the case was closed from on high (e.g. the Haut de la Garenne investigation in Jersey).

Videos have emerged of children being raped, tortured and murdered with a celebrity, aristocrat or politician present only for the video to disappear in police custody. Accusers have been mysteriously murdered or disappeared completely.

Common Law High Courts, comprising lawyers, witnesses, experts and judges, have heard evidence from multiple sources demonstrating an organised ring of paedophiles in the establishment of many Western nations (notably Britain, the US, The Netherlands and Australia) only for the media to ignore all their findings.

### *Education*

We have already discussed the appalling education of children whereby they are taught lies about most things and conditioned to believe irrational things; such as transgender issues. Kids under ten are encouraged to transition and even sometimes given hormone medication without parental consent. They are conditioned to believe that they can choose their sex and identity without parental control. Kids have been told that their parents need their consent to hug them. Kids are sexualised at an early age to condition them to be willing victims of paedophilia. This is being instigated by the UN, through UNESCO and the WHO, directly into town councils.

Children now emerge from school with no understanding of the basics (reading, writing, and arithmetic), no ability to think critically, no ability to apply logic, no ability to question and no understanding of history. But they are programmed to submit to Progressive narratives, hate Right Wing traditional views, hate White privilege, be a victim, be selfish, accept Green propaganda, accept Queer theory and so on.

### *No future*

In many areas kids today have no chance of development as previous generations did. For the first time in 100 years this generation is worse off in many areas than previous generations.

Kids have very difficult choices regarding getting a job. White male teenagers face the worst situation. They are blamed for being White, and for being male by Intersectionalists. Black people, marginalised groups, victim groups and women will all be prioritised for



employment. White boys also come out of school with the worst grades. This is why many turn towards crime, gangs, drugs, or just get depressed and suicidal.

But even for kids that manage to get a decent job their future is bleak. House prices are beyond belief. Small flats in London cost around £2000 a month. In my area (Worthing) it is around £1400-1500). Prospective tenants need to find six months rent in advance and a deposit plus guarantors. Very few young adults will ever be able to buy a house. Average house prices differ but in the south it is around £350K for a small house. In some desirable areas even small terraced houses are going for £500K. Rising interest rates due to inflation (created by the government) mean that mortgages are now too expensive to even consider.

Many social functions in towns have disappeared, either because of Covid effects or previous deliberate degrading. Rural villages have seen all the centres of community removed: Post Offices, local pubs, local shops, local churches, local policemen on the beat, libraries, council facilities (e.g. day centres). Children and teenagers in such areas have literally nothing to do. Removal of bus services mean that they cannot even get to the nearest town for a pint. Their lives appear to be pointless to them. They are desperate to live in the city (that is the cabal's purpose) but cannot afford to live there; even if they could find a job.

In large towns kids are also isolated but for different reasons. The high cost of living means that even if they have a job and a bedsit they have no money left. Beer prices are through the roof in clubs in places like Brighton; up to £7 a pint. Some beverages are even higher. Going on the razzle on a Friday night in a club will cost easily £100. You will also need a taxi and even a three-mile journey will cost £12. Transport to work is also expensive, even on buses if you are lucky enough to be on a bus route. If you drive you will be hammered by ridiculous car parking charges; especially in Green towns like Brighton which hate cars but live off taxing them.<sup>27</sup>

Kids notably live off take-aways and kebabs but the cost of living crisis is making this impossible. Yet kids have also been failed in that they have not been taught to fend for themselves. Most teenagers cannot cook. Surveys have shown that kids cannot boil an egg, can't cook toast, cannot cook a sausage properly, or don't know where milk comes from. One teenager watching me cook once asked what that green stuff was that I used. He was referring to herbs. Kids today (with some exceptions) only know how to put boiling water on to pot noodles or microwave a ready meal (both of which will cause harm to the body)

This is why kids live off their cell phones with their heads glued to a screen. They have no other world to thrive in.

### *Summary*

Children are being assaulted in every area of their lives. They are being sacrificed on the altar of modernity and Elite strategies.

## **Women**

### *Transgender issues*

Women's rights (which took decades to affirm) are being assaulted all the time as a result of transgenderism.

- Women's only spaces are being invaded by biological males claiming to be women.
- Women are being assaulted in private areas by biological males claiming to be women.

- Girls are being assaulted in school toilets by boys claiming to be girls.
- Girls are too scared to go to the toilet in school, even for menstrual issues, due to fear of attack.
- Women's prisons are admitting biological males claiming to be women, including sex offenders, whereupon women are raped and assaulted.
- Biological men are competing in female-only sports and out-performing women due to biological advantages.
- At a recent sports day in a school, not a single girl won any prize because all the prizes were taken by boys claiming to be girls.

Women standing up for female rights are being attacked by men posing as women. Some have been physically assaulted and face death threats. This illegal behaviour is being condoned by the police or a blind eye is being turned.

### *Pornography*

This is now freely available everywhere. Anyone with a broadband phone can access hardcore pornography. This normalises extreme sexual practices that are observed by children and young teenagers, which are then copied as normal behaviour. This accounts for a number of serious issues amongst school kids. Dating now involves sending someone an image of your genitals for example. Television programmes undergird this in dating shows featuring naked people.

All of this objectifies and exploits women. It also thrusts new norms upon women in relationships, such as making anal sex a norm. A woman refusing this is vilified as a prude.

### *Rap music*

Certain types of Rap music are highly misogynistic. Women, in these songs, are described as 'hoes' (whores) and routinely made the objects of violence and castigation.

### *Movies*

Films picturing low-life ghettos, criminal hangouts (cribs), drug abuse situations and such like routinely show abuse of women. Ladies are often portrayed as being beaten, raped, abused, derisively treated, spoken to roughly and so on. This is portrayed as the norm. Women in these situations are servile and compliant.

### *Summary*

All of these degrade women in society.

The job of men is to protect women and make safe spaces for them. The prime safe space is the home whereby a husband protects his wife and cherishes her above all others. Society has ripped this apart and traditional marriages are now the minority.

Men are no longer treating women with respect in society. Most do not open doors for them or offer them a seat on a bus. Radical Feminists have fostered this, which is now backfiring. Women are treated the same as men and can thus be treated with similar derision and brutal force. Thus women are pushed, shoved, slapped, cursed and worse routinely in certain levels of society.

### **Young White men**

I have already covered this to some degree.

Young White men are now the most disadvantaged people in society. Their prospects are worse than anyone else. They perform badly at school being overtaken by girls plus

Chinese and Indian students. They leave school with fewer qualifications. Most of them leave school with no hope or aspiration unless they have a specific trade in mind (such as an apprentice engineer) or have a contact in a trade that will get them an apprenticeship job, such as plastering or plumbing.

They struggle with relationships partly because they have no prospects. Any relationships tend to be base one-night stands that only fuel self-loathing.

Accordingly, many fall into various support mechanisms to hide their hopelessness: drugs, alcohol (if they can afford it), constantly watching video games (especially violent ones) and such like. There are people now that upload videos of themselves playing video games, which get many views! Go figure!

On top of this futility, these guys are continually attacked by Intersectionalists and others as being the cause of humanity's evils. They are blamed for being White and for being male (as if they could do anything about it). They are called privileged when their lives have been rubbish. They are called colonialists when they don't know anything about imperialism. They are called the beneficiaries of slave trading when their past includes no such thing or their ancestors were serfs. They are told that only Black lives matter and people that have publicly stated that White lives matter have been arrested.

There are two ways out of this. One is to ignore the matter, develop some steel and forge a way forward for yourself against the odds. The other is to capitulate, which many poor souls do. You can see videos of feeble young White teenagers insisting that they are the problem and apologising for their White privilege. No wonder that confused young White males want to be girls.

### **Old people**

Historic societies, even the most brutal such as Assyria, still held old people in respect and honour. The elderly were held to be the wise in society that should be consulted on important issues. This has disappeared in the West.

Old people are now considered to be what Kissinger says, are '*useless eaters*'. They are a stain on society that just soak up money and medical resources. They do no good and add no value.

This derision was exemplified in the Covid crisis when the elderly were literally sacrificed. They were murdered by government strategies as I have explained many times (even in this paper). This is no exaggeration; decisions were calmly made that would kill the elderly by design. Remdesivir, Midazolam and morphine were only part of this story that also includes ventilators, DNR<sup>28</sup> notices without consent, removal from hospital into care homes and so on. Old people with treatable diseases were left untreated (I have seen this with my own eyes). Old people in hospital were left uncared for without food or water and lying in their own filth (this is still going on today). They were thus put on a 'care pathway' (left to die under sedation) instead of being given aid.

Lockdowns worked against the old people more than anyone else, excepting children. In the early stages of the first one old folk could not even get food (I struggled to do this for some weeks). The government did not even arrange for food boxes for most sections of elderly society (such as myself despite being isolated, highly vulnerable with a terminal disease. I had to ignore lockdown rules [which I did anyway] and get a friend to drive me many miles to get food. [Initially, online stores could not cope with demand and delivery

dates were weeks in advance.] Some old people literally starved because of a government intervention.

Rising energy prices, caused by government actions,<sup>29</sup> also led to deaths of old people who could not afford both food and warmth. There were multiple stories of old ladies sitting in a freezing room covered in blankets unable to move. Far more people die from the cold than heat every year.

### **Interim conclusion**

The sacrifice of certain sections of the population is deliberate. It forms part of the Elite's eugenics and Malthusian strategies for depopulation. But it also forms a part of the Luciferian modern Baalism, which thrives on sacrifice.

For example, the cabal's plans in the Ukraine conflict are very obvious to see. Peace could have been secured in February / March 2022 when Putin tried three times to initiate a cease-fire. What stopped this? The West. NATO and particularly Boris Johnson demanded that Zelensky continue this proxy war of attrition against Russia with promises of money and supplies. Thus the insane war continued. All that this did was to create hundreds of thousands of dead Ukrainians since Russia is better prepared and equipped for war than either the Ukraine or the combined West (which is fast running out of essential munitions).

So the war rolled on. More and more Ukrainians needlessly died. The Elite's purpose in this is chiefly to wear Russia down to such a degree that there is regime change, Putin disappears, and then Russia is Balkanised into smaller sections dominated by the West and raped for resources (which happened after Yeltsin). The main purpose involves geopolitics. However, a secondary interest is that the Luciferian Elite thrives on death and destruction because they are Satanists. The piles of dead people literally gives these insane psychopaths a thrill, just like the piles of dead sacrificial victims excited the Aztecs to think that they served their god and cheered when a heart was ripped out.

Yes this is a fact. The cabal loves sacrificial victims just as much as Baal and Molech worshippers. [In fact, you can make the case that many in the Elite actually derive from Canaanite tribes.]

## **Conclusion**

The problem with writing this paper was knowing when to stop. Not only is there a vast store of insane things already operational in society, but each day more craziness just keeps on coming. There are whole areas of madness that I haven't even opened up – but I have to stop at some point.

The new levels being reached are staggering and they are enforced by law: boys can be girls, girls can be boys. People can become cats or moons or reptiles. There are hundreds of genders and a multitude of impossible to remember pronouns. Children as young as four can have a sex life and a sexual partner. To question this leads you to being castigated for hatred and possibly sanctioned by the law or by losing your job. Black people can openly say that White people should be killed and this is tolerated but a White person saying the wrong descriptive word about Black people can be imprisoned. Transgender activists can

promote hatred and violence against heterosexual people but if a heterosexual person merely offends a transgender person with a wrong pronoun they get arrested.

The Western world is not only ungodly, it is now irrational and demented. None of this is being accepted by the majority of the world's population that has retained traditional common sense values.

The key point is that as society becomes more embedded with satanic strategies managed by Satan's proxies (the cabal) so mankind becomes more insane. This psychosis will become worse.
